BARBARA AND MEL SAPSOWITZ

MY PARENTS LEGACY... BY RABBI MARNA SAPSOWITZ

My mother, Barbara Rubin Sapsowitz, was a teacher, not just by profession, but constitutionally. She was a teacher to her core. Shortly after I was born, she returned to her teaching job --- but, in 1959, she was made to feel guilty for not staying home with her baby, so she left her job and became a full-time homemaker.

The influx of Soviet Jewish immigrants to American communities happened just as I went off to college. My mother believed strongly that the key to these new immigrants' success in their new land was a mastery of English, and she rolled up her sleeves to make that happen.

She got to know each newcomer's families, their education, their work histories, their skill sets. She tested each individual to determine their language skills. She selected level-appropriate learning materials for each student. She recruited and trained some 40 volunteer tutors from the community and made sure they had the training they needed to be effective tutors.

She made sure the new arrivals got introductions to American currency, the banking system and grocery stores. In addition, she shnorred tickets to cultural events at places like the Masonic Temple and the University of Scranton for them, anything that would introduce them to American culture. Sadly, her work was cut short by her death in 1995.

My dad was a Chemistry major at Brooklyn College, where he met mother, the love of his life. Our family moved from New York to Northeast PA in 1965 when my Dad's company, Topps Chewing Gum, relocated. He eventually became Topps' Vice President of Research and Development.

My parents built a life in the Scranton area, developed close friendships, and became involved with and committed to community life.

After my mother's death, my father honored her memory by establishing and funding the production of the JFS Community Matters newsletter. In this way, he maintained his connection with the Scranton community for the past 25 years.

My parents were loving and generous people, and I am happy to enable the continuation of the newsletter in their memory.


HERBERT ROSEN

MY FATHER'S LEGACY... BY NANCY ROSEN

My dad, Herb Rosen, of Stroudsburg died January 28, 2021. He and my mom, the late Sylvia Rosen, shared 64 years of marriage at the time of her death on June 9, 2019. My dad, along with his brothers Al and David took over the business established by his father, Nathan, founded in Hazelton in 1919. The brothers successfully grew Rosen's Furniture and expanded their business into the Stroudsburg area. During the mid-80's the Rosen brothers started on the road to retirement. Rosen's Furniture was a longtime, well-respected business for many years.

My dad immediately got involved with synagogue life when they moved to Stroudsburg when I was a young child. He was a humble man, who lived a simple life and always wanted to help others. He liked classical music, played a baby grand piano, and read the New York Times. My mom, Sylvia, played a big part in my dad's success and was a seamstress, an artist, a gourmet chef, and had a beautiful singing voice.

My parents wanted others to be helped through the blessings of their success and became known as local philanthropists. They thought of other people before they thought of themselves. Through the Herb Rosen Charitable Remainder Unitrust, with a major gift in the amount of \$820,000, my dad wanted to have a significant, positive impact and continue his legacy. Jewish Family Service was an organization that my parents loved so dearly, and they wanted to make sure that JFS could provide critical services to the community now and forever.

MENTAL HEALTH SERVICES

IF YOU NEED SOMEONE TO TALK TO, WE'RE HERE TO LISTEN

Jewish Family Service provides confidential, professional counseling services for families, couples, individuals and groups experiencing a variety of problem areas. Treatment areas include addiction, domestic abuse, depression, panic and anxiety disorders and adjustment difficulties. Relationship enhancement skills are also provided to improve communication, parenting, self-esteem and general quality of life. Information and referral to community resources are also offered.

Jewish Family Service is a participating provider with many insurance companies and accepts Medicare and Medicaid. Sliding fee scale is also offered based on family size and income. Our social workers are licensed clinical social workers in the State of Pennsylvania. Jewish Family Service is accredited for outpatient mental health service by the Council on Accreditation. 

REFERRAL SOURCES



In March of 2021, we successfully implemented our new Electronic Health Records (EHR) software. Billing our client sessions through our new EHR began in May of 2021. We have also been successfully receiving revenue for those sessions billed in the EHR software. As we continue to customize for our needs, our counselors continue training and utilizing the software for their counseling sessions.

FINANCIAL AID/ HOLIDAY ASSISTANCE

Short-term financial assistance for rent, utilities, food or other emergency needs is provided for individuals and families experiencing financial difficulties. The Holiday Assistance Program ensures that the beauty of the Jewish Holidays is shared throughout the year.

FAMILY LIFE EDUCATION

JFS offers education and enrichment through lectures, guest speakers, workshops on topics relevant to family life, Jewish identity and current issues. Education and support groups provide educational, supportive, and preventive services to improve emotional well-being, and promote self-sufficiency, personal growth, development, resilience, and wellness.

ADULT GUARDIANSHIP OF PERSON

HELPING OLDER ADULTS AROUND ISSUES OF ISOLATION ILLNESS AND DEPENDENCY

JFS provides comprehensive Guardianship of Person Service to those individuals who have been determined by the court to be incapacitated and no longer able to make their own life decisions. Jewish Family Service's duties as Guardian of Person include making daily decisions about the individual's personal affairs, maximizing his/her right to selfdetermination, and:

- · Asserts the rights and interests of the individual
- Respects the wishes and preferences of the individual to the greatest extent possible
- Encourages the individual to participate to the maximum extent of his/her abilities in all decisions
- Provides required documentation to the court in a timely fashion.
- Visits with the individual once a month and more frequently as needed
- Is available 24 hours a day, 7 days a week

JFS is accredited by the Council on Accreditation for Guardianship of Person Service. Referrals may be made by individuals within the community, hospitals, long-term living facilities, physicians, attorneys, the court and social service agencies. Adult Guardianship of Person is a fee for service program. All guardianship fees are reported to and approved by the court. This program is funded, in part, by the Pennsylvania Department of Aging and the Lackawanna County Board of Commissioners through the Lackawanna County Area Agency on Aging.

OLDER ADULT SERVICES/ CASE MANAGEMENT

PROMOTING DIGNITY, SELF RESPECT AND INDEPENDENCE FOR THOSE IN NEED

The purpose of the Older Adult Program at Jewish Family Service of Northeastern Pennsylvania is to promote and preserve the dignity, self-respect and independence of the individual to the fullest extent possible. The Older Adult Program assists individuals and their families in making choices that foster maximum independence in daily living. Licensed Social Workers and experienced, compassionate volunteers work together to coordinate services for eligible individuals. Consultations are by appointment. Evening hours and home visits are available. Fees for service will be charged according to a set fee or a sliding scale based on family size and income. No one will be denied service because of an inability to pay a fee. JFS is accredited by the Counsel on Accreditation for Case Management. Some services may be covered by your health insurance or Medicare.

DENTALCARE CENTER

VOLUNTEER DENTAL CARE PROVIDED IN PARTNERSHIP WITH VOLUNTEERS FROM THE SCRANTON DISTRICT DENTAL SOCIETY AND FORTIS INSTITUTE

The Non-Sectarian DentalCare Center has been part of Jewish Family Service since 1920. This unique service is one of only two such clinics affiliated with a JFS in the United States. Jewish Family Service administers the DentalCare Center in partnership with licensed volunteer dentists from the Scranton District Dental Society and Fortis Institute to provide professional dental services. All treatments are provided in private dental offices with initial examination and diagnosis at Fortis Institute Dental Hygiene Clinic, Scranton. Care includes a complete dental examination, x-rays, prophylaxis, restorations and extractions. Specialized services such as prosthodontics, endodontics, orthodontics, periodontal treatment and oral surgery are also offered at a reduced fee to the client. Residents of Lackawanna County are eligible for services if they are financially unable to afford dental care. Eligibility is determined by a screening and application process completed by Jewish Family Service. The majority of patients receiving dental services have at least one family member employed, is on unemployment, supported by Social Security or Social Security Disability benefits.

FOOD INSECURITY

MAE S. GELB FOOD PANTRY

The Mae S. Gelb Kosher Food Pantry, established in January 2001, was developed to provide assistance with food and other necessary household items to families and individuals during times of significant financial stress. Clients include the elderly who may be isolated and living on a limited income, unemployed adults in need of interim assistance and members of our community who are struggling financially due to difficult family situations or declining health. Clients can make a self-referral to the Kosher Food Pantry or may be referred by family, friends and/or other social service agencies. If a client is known to this agency and receiving services in another program area, their social worker may also refer. An appointment must be made with an agency social worker to complete a Kosher Food Pantry screening form. If determined that the client is eligible for pantry services, the worker will accompany the client to shop in the pantry area. The Food Pantry is supported by donations from the Gelb Foundation, generous community members, synagogues and other Jewish organizations.

KOSHER MEALS ON WHEELS

JFS, in cooperation with the Meals on Wheels Office of Northeastern Pennsylvania and the Jewish Home of Eastern Pennsylvania, delivers kosher meals to those in need. Kosher Meals on Wheels (KMOW) are available to those people in our community who adhere to Kosher dietary requirements. The program serves those who are temporarily or permanently disabled and who require outside support in order to function independently at home. Kosher Meals on Wheels provides adequate, well-balanced, home delivered meals to those who are unable to shop for and unable to prepare meals for themselves. adietary guidelines. Kosher Meals on Wheels is able to accommodate most special diets, such as diabetic, low salt, low fat, chopped, etc. Recipients are billed monthly for Kosher Meals on Wheels. Funding for meals may be available from the Lackawanna County Area Agency on Aging for senior citizens who have a lower income and meet the required guidelines.

FRESH FOOD PANTRY

JFS introduced our Fresh Produce Pantry two years ago. With produce and chickens donated, we were able to provide onions, potatoes, carrots, apples and chickens to those in need during Passover and Rosh Hashanah. The program is an extension of the Mae S. Gelb Food Pantry and our Holiday Assistance program.





VOLUNTEERING AT JFS

"Hello, my name is Nancy Post and I'm a JFS Volunteeer."

Born and raised in Scranton I've lived here all my life raising 2 children with my husband at our home in Green Ridge. I retired in 2019 after more than 20 years with Voluntary Action Center, most recently as Director of Volunteer Initiatives.

Volunteering is in my DNA. I have early memories of my mother volunteering at the Pine Cupboard Snack Bar at CMC as a Junior League member and both my parents volunteering extensively at church. When I joined the Jr. League of Scranton years ago, volunteering also became an important part of my life and taught me the importance and the reward of community involvement.

I have volunteered for a wide variety of organizations incuding Robert Dale Chorale Board member, Literacy volunteer, co-chair of Race for the Cure, co-chair of Santa's Holiday World, Abington Library, church boards and committees. After spending much of my professional life working with seniors and senior volunteers; I've become very concerned with the issue of senior isolation. I was aware of the excellent senior programs and leadership at JFS and joined their volunteer program just as COVID intervened. It was suggested that I put my efforts to telephone "visiting". These calls quickly became another layer of safety and support to homebound elderly.

I am thankful to have had the opportunity to help during this time of need. Every time I speak with my "person" it is a reward in itself and I hope to begin in-person visits soon!
